*The customer shall be responsible for completing all paperwork and paying all necessary fees for applications, licenses, and permits. The Customer is responsible for obtaining the appropriate license from the State of Kansas and is responsible for being legally authorized to hunt, including a hunter's safety permit for a customer born after July 1, 1957. **IF THE CUSTOMER IS UNABLE TO HUNT BECAUSE OF NOT HAVING OBTAINED THE APPROPRIATE LICENSES AND PERMITS, THE CUSTOMER'S DEPOSIT SHALL NOT BE REFUNDED, EXCEPT FOR PERMITS TIMELY APPLIED FOR AND NOT ISSUED.** Mill Creek shall provide Customer with all applications and paperwork necessary for the Customer to apply for a hunting permit for the type of hunt the Customer desire, which shall be supplied at least two (2) weeks prior to application deadline.*

Mill Creek does not guarantee the success of the Customer on any hunt.

All hunts shall be conducted under the rules and regulations of the State of Kansas as determined by Mill Creek.

The Customer assumes all risks known and unknown relating to the hunt and releases and covenants with Mill Creek, as part of the consideration of this contract, not to make any claim against Mill Creek resulting from the hunt.

Any and all tree stands, ground blinds, and shooting towers shall not be moved or modified by any Customer unless prior consent given by Mill Creek.

There is no smoking allowed in any tree stand, ground blind, and/or shooting tower. All trash, chewing tobacco, urine bottles, and any other debris left by Customer shall and must be removed each time prior to leaving a hunting location.

Under no circumstance is the Customer allowed to go scouting, walking, or site seeing while in the field. Customer shall walk from vehicle to stand and from stand to vehicle only. Should the Customer shoot a deer, the Customer is not to search or attempt to recover the deer until Mill Creek has given the consent to do so.

Any deer harvested must have a minimum gross score of 140". Any Customer who harvests a deer with a gross score less than 140" will be charged a \$1000.00 fine. All sheds and/or deer skulls found on the land hunted shall be property of Mill Creek.

All wounds will be treated as a harvested deer, unless and until Mill Creek has determined, at their discretion the wound to be or not to be fatal. Mill Creek shall be responsible for all field care of deer. Customer is responsible for all processing and taxidermy. Mill Creek has an on-site taxidermist. Please note that Mill Creek will not tolerate any waste of any game animal.

Mill Creek provides an on-site target range for both archery and rifle.
